**Sub.:Permission to render the Voluntary Services for providing support in Uploading of Online Applications of the Stranded Persons in Nagpur Division, on the Govt. Portal**

Dear Sir,

Since the time Govt. has permitted the "Stranded Persons" to make an online application on portal <http://covid19.mhpolice.in> I have noticed the following practical difficulties .

1. Stranded Labours are mostly illiterate and thus they are not familiar with online activities/procedures to be followed in this regard and as such they are unable to upload an application for permission to travel which is needed for them.
2. There are many other citizens who also find it difficult to make an online application for varied reasons.
3. The Cyber Caffe are not operational at this juncture.
4. There is hardly any support available in this regard.

Due to above limitations the large number of stranded persons are visiting the Collectorate, SDO's, Police Authorities and Other District Authorities with documents and asking them either to upload the same or grant permissions on the basis of documents available with them. At the same time those who are trying to upload the same are doing it in an undesired manner and as such these applications are getting rejected which is evident from the record of applications rejected. Further it is learnt that these applicants are calling the district administration authorities frequently and that too at any time resulting into wasting of their quality time which they can otherwise utilise for fruitful exercises.

Gathering of such applicants in large number in front of District Authorities have been noticed which is likely to create pressure on District Administration at one end and breaking the social distancing mandate at other end.

It is also heard from some affected one's that some persons those who are providing these services are charging monetarily but the Stranded Labours find it difficult to pay and as **such some kind of help to them is much needed at this juncture as well as in days to come looking to the extension of lockdown .**

Since I in individual capacity has been instrumental in helping in this COVID-19 Lockdown related situation in whatever possible manner for last 45 days, and therefore as further step in this endeavour and having regard to the exiting situation, where every stranded person wants to reach to his/her home town, I am intending to offer from the bottom of my heart to provide the services relating to uploading of online applications on the Govt. web portal with following modus operendi .

1. The Stranded Person can send the required documents on following WhatsApp Mobile No. or mail ID and can also contact telephonically.

2. On receipt of Documents if the same is found in order then we shall upload the same on the above portal <http://covid19.mhpolice.in> and the token number shall be communicated to the concerned Stranded Person.
3. If the documents are not in order then our above refereed persons shall contact the concerned stranded person on **Phone** and shall ask him to send the proper documents and shall apply once the documents are found in order.
4. We shall also forward the permission to the concerned person on his/her mobile or mail ID.
5. Needless to mention that these services shall be voluntary in nature and as a matter of our small contribution to stranded persons in the time of need of COVID-19 related Lockdown situation. At the same time, it will be convenient to the permitting authority to dispose of the applications quickly as we shall ensure that the application is complete in all respect.
6. Even we can Upload the applications again by calling proper documents which are rejected at your end for discrepancies.

I request your good self to permit me to render these services in the larger Interest of Stranded Persons. **Further your good self may also provide our above referred WhatsApp Numbers and email ID to the Stranded Persons who are approaching your office for uploading the applications for permission to Travel.** The secrecy will be maintained about the Permission and document received at our end and there will not be any occasion to meet them in person.

Requesting you to permit me to render these services in this time of need.
